You are reading the privacy policy of NaleiaYachting.com. This website is brought to you by Naleia Discovery Travel Company (hereinafter as NDT), registered with: VAT-UE PL8842595742, Łokietka 5/2 street, 58-100 Świdnica, Poland. NDT is registered in the tour organizers registry of Lower Silesia province under the number 615/9/2015. This privacy is for you to learn how we collect and process your data. Please read it carefully.

## What data do we collect about you?

We will collect the following data about you:

- personal data which you provide in the booking form and in the organizational processes following,
- information which you provide along with your newsletter subscription,
- monitoring and statistical data gathered by cookies (including IP address, geographical location, browser type, referral source length of visit, page views and navigation paths.
- any data we directly ask for: feedback, testimonies, photos, opinion polls, etc...

## How do we use your personal data?

We use the collected data for the following purposes:

- administration & organizational processes,
- behavioural analysis, statistical analysis, research,
- marketing and communications,
- billing and order fulfilment,
- notifications of changes to the website,
- improvement of services.

## Disclosure of your personal data

We might disclose your personal data to the following entities:

- our partners which need your data to deliver our services (lawful regulations),
- law enforcement entities if any such need occurs.

Except as provided in this policy, we will not disclose your personal information to third parties.

## Security

We add any possible technical means of securing your data when we process it. We do this by storing your data on secure servers, encrypting the communications with our partners, and many others. As much as our processes are concerned we do all reasonable effort to ensure security. However, you acknowledge that the use of the internet cannot be completely secured and therefore we cannot fully guarantee the security or integrity of any data that you transfer to us and we transfer to you.

## Usage of cookies

We use cookies on our website. We use it for:

- improving our website based on your website usage patterns,
- collecting statistical data on the usage of our website,
- improving our services.

This information will not contain any personal information about you. This data contains information about your electronic device such as your IP address, your browser, and tracks your website usage time. This information cannot identify you personally.

2. provide enough information to identify you (see above).
